MASTER PLANNING AND FUNDING UPDATE

TCB/RRHA submitted the Master Plan for review as a Community Unit Plan (CUP) application to the City of Richmond in December 2020. The plan includes input from Creighton resident participation in Fall 2020. The CUP was approved by the Planning Commission on July 6, 2021. It is now scheduled to go to City Council on September 13th.



In addition, the first phase of the redevelopment (Phase A) has received a 9% LIHTC (Low Income Housing Tax Credit) award from Virginia Housing for \$13 million. Phase A includes the new construction of 68 units.

An application was also submitted to the Virginia Department of Housing and Community Development (DHCD) on April 30th. The application was unfortunately unsuccessful, but we plan to resubmit the application for the next round in October 2021.
