WHAT WE'VE HEARD SO FAR: Community Expo


- What does it mean to uplift current efforts in Jackson Ward?

- How do we address the consequences of historic red lining in this plan?



Butterflies are a metaphor representing spiritual rebirth, transformation, change, hope, and life.




Gilpin was born in Richmond, VAirginia, to Peter Peter Gilpin (a factory worker) & Caroline White (a nurse); he attended St. Francis RC School in that city. He started work as an apprentice in the Richmond Planet print shop before finding his career in theater.



Lillie Ann Estes set the standard for community organizing in Richmond. Her apartmentin Gilpin Court became the headquarters for her efforts to develop strategies and alliances from Ricmond to Washingtooooon and Boston to uplift the poor and disadvantaged.



Sam Banks worked for the schools for 37 years, as an African American in the era before desegregation. According to his recollection, Mr. Banks was the second African American to become a teacher in the Richmond City Schools.





Calhoun Recreation Center Greenway Corridor with Trails & Social Spaces/ Open green Space/Existing Playground/Existing Parking Lot





PEOPLE

"Improve outcomes of households living in the target housing related to **employment** and **income, health**, and children's **education**."



HOUSING

"Replace distressed public and assisted housing with **highquality mixed-income housing** that is well-managed and responsive to the needs of the surrounding neighborhood."
