MASTER PLANNING AND FUNDING UPDATE

TCB/RRHA submitted the Master Plan for review as a Community Unit Plan (CUP) application to the City of Richmond in December 2020.

We have been working with the City departments (Planning, Public Works, Public Utilities, Zoning) to prepare the CUP which was introduced to City Council on June 14, 2021.



In addition, we have submitted an application for 9% Low Income Housing Tax Credits to Virginia Housing on March 18. An application was also submitted to the Virginia Department of Housing and Community Development on April 30. Awards for both applications are expected to be announced this summer.
